

Accountant	Performs intermediate level of financial activities; analyzes and prepares related studies and reports for use in various accounting functions
Account Director	Responsible for identification and evaluation of gas supply opportunities, gas transportation, gas storage, operational gas sales, negotiating, monitoring and managing related agreements for key accounts and coordinating implementation of associated projects.
Account Manager	Provides service and maintains relations with transmission customers. Negotiates transportation agreements; works with customers to identify concerns, resolve issues and provides information to explain company procedures, positions and philosophies
Commercial Business Analyst	Performs an intermediate level of work related to nominations, confirmation, and scheduling activities for natural gas or natural gas liquids transportation. Assists in the preparation, analysis, interpretation, and communication of information from complex contracts. Assists with preparation and maintenance of financial models pertaining to natural gas or natural gas liquids commercial activities.
Contract Analyst	Prepares, negotiates, interprets, and maintains complex gas contracts pertaining to operational gas purchase, operational gas sales, transport, interconnects, and related transactions and information.
Director-Engineering	Directs engineering and construction activities to assure that projects are completed in accordance with applicable professional standards, design-centered procedures and corporate procedures and guidelines.
Director-Pipeline Operations	Oversees all plant and transmission activities for region including pipeline construction and maintenance, engineering, compliance with DOT regulations and FERC construction and maintenance regulations, and budgets
Director-Physical Optimization- Interstate	Responsible for short-term and long-term commercial activities for the interstate pipelines.
Director- Physical Optimization- Intrastate	Responsible for short-term and long-term commercial activities for the intrastate pipelines.
Director- Rates and Regulatory Affairs	Manages and/or coordinates preparation of data requests, testimony, and filings related to state and federal regulatory processes.
Director- Transportation and	Manages and directs transportation requirements and support

Support Services	services for contract administration, scheduling, and business processes for ONEOK Partners' natural gas pipelines, including all related systems applications.
Field Engineer	Performs engineering duties related to one or more functional areas that may include: pipeline system planning and analysis, gas measurement, gas analysis, and measurement station design; facility operation; and/or estimating, designing, and coordinating pipeline construction projects.
Financial Analyst	Assists with preparation and maintenance of financial models pertaining to gas transportation, and storage services. Provides economic analysis activities related to new business development projects, capital projects, acquisitions and/or other strategic opportunities.
Manager- Account Management	Optimize revenues derived from underutilized pipeline space, line pack and storage on interstate pipelines and ensure compliance with tariff and FERC guidelines to achieve organizational objectives.
Manager- Business Development	Manage the development, coordination, and analysis activities related to new business development projects, acquisitions, divestitures, and other strategic business opportunities for ONEOK Partners'. Assist in strategic planning efforts and analysis for existing business segments.
Manager-Gas Control	Responsible for directing the flow of natural gas through the pipeline systems.
Manager-Market Analysis and Strategy	Manages the strategic and tactical oversight with a focus on market and competitor analysis to implement company's objectives for each of the interstate and intrastate pipelines. Provides guidance and works with the commercial group to develop and enhance service offerings; assesses and recommends regulatory strategy for any facility expansions; interprets and develops cost/rates data in the context of commercial or operational issues and opportunities; provides regulatory support related to proposed acquisitions. Details how FERC filings and ruling can impact the marketplace and provides guidance to adapt to those changes.
Manager- Operational Accounting	Manages monthly natural gas pipelines and general accounting functions.
Manager-Optimization	Directs pipeline modeling and optimization activities to ensure that models accurately reflect actual and proposed pipeline operations. Develops pipeline system recommendations to optimize commercial prospects and operations efficiencies.

Manager- Pipeline Integrity	Directs pipeline safety programs, procedures, and standards for the natural gas pipeline systems to ensure compliance with Federal Pipeline Safety Regulations. Directs pipeline integrity programs, procedures, standards, and projects to ensure the continued operating integrity of the natural gas pipeline systems and compliance with the Pipeline Integrity Rule. Directs programs to effectively maintain Data Management, Engineering Records, and Document Control required for compliance. Directs requirements of Pipeline Security.
Manager- Pipeline Systems/Engineer	Directs daily activities of the engineering services employees and develops strategic planning and guidance related to general operations, Geographic Information Systems (GIS), pipeline systems, record keeping, project management, and technology initiatives across the division.
Operating Engineer	Supports ONEOK Partners' operations by continuing to improve the assessment and remediation programs within the Pipeline Integrity Management Program and meet the compliance expectations of federal regulations.
Pipeline Controller	Monitors, adjusts, and/or controls flow of gas or natural gas liquids through the pipeline system in a safe, reliable, compliant and efficient manner. This includes distribution, transmission, gathering, storage and processing systems.
Pipeline System Planner	Performs duties related to pipeline system planning and analysis, system operation, construction estimates; and/or design and coordination of pipeline construction projects.
Regulatory Analyst	Prepares timely regulatory filings including: tariff change filings, rate change filings, certificate filings, compliance, and other filings and reports required by Federal and State regulatory agencies.
Regulatory Compliance Coordinator	Implements and administers regulatory compliance programs related to applicable FERC regulations and tariff obligations for business units operating interstate natural gas and/or natural gas liquids pipelines.
Scheduler	Performs work related to nomination, confirmation, and scheduling activities for intrastate and interstate pipelines.
Supervisor- Nominations/Scheduling	Supervises employees engaged in activities related to nominations, confirmations and scheduling activities of natural gas intrastate and interstate pipeline systems. This includes transmission and storage.
Supervisor- Pipeline Control	Coordinates and directs the flow of natural gas through the pipeline systems in a safe, reliable, compliant and efficient manner. Flow analysis for operational design and commercial development

	projects.
Supervisor- Pipeline Operations	Supervises and directs employees engaged in activities related to maintenance, operations, and measurement of gathering and/or pipeline system.
VP- Commercial Natural Gas Pipelines	Responsible for the management and planning for both the interstate and intrastate pipelines. Responsible for directing commercial staff in the origination of new markets for short and long term pipeline transportation marketing. Also responsible for maintaining relations with customers.
VP- Natural Gas Pipelines Operations	Responsible for the operation of natural gas pipelines of ONEOK Partners' including interstate and intrastate natural gas pipelines and storages.
VP- Rates & Regulatory Affairs	Responsible for the rates and regulatory strategy for ONEOK Partners' interstate and certain intrastate natural gas pipelines and natural gas liquids pipelines.
